**Item 9: Other Events**

Aboitiz Power Corporation (AboitizPower) received the Certificate of Registration from the Department of Energy (DOE) as a Renewable Energy (RE) Developer for the 45.0 MW Nalatang B Hydroelectric Power Plant located in the Municipality of Kabayan, Benguet Province (the "Nalatang Project"). DOE awarded the Certificate of Registration to AboitizPower following the approval of the assignment of the Hydropower Service Contract of the Nalatang Project from PNOC Renewables Corporation, the original RE Developer.


With the issuance of the Certificate of Registration, AboitizPower or its assignee can now start on the pre-development stage of the Nalatang Project, which is expected to be completed in the first quarter of 2019.
