Hedcor Bukidnon, Inc., a wholly owned subsidiary of Aboitiz Power Corporation through Aboitiz Renewables, Inc., obtained loans and credit accommodations from a consortium of lender-banks in the amount of up to Php10 Billion to finance the development, construction, operation and maintenance of its 68.8MW hydroelectric power generation facility located in Manolo Fortich, Bukidnon.

BPI Capital Corporation acted as Mandated Lead Arranger and Bookrunner, while Bank of the Philippine Islands - Asset Management and Trust Group is acting as Trustee and Facility Agent.
