Item 9: Other Matters

Aboitiz Power Corporation (AboitizPower) was informed by SN Aboitiz Power-Magat, Inc. (SNAP Magat) that it has signed a Notes Facility Agreement with Bank of the Philippine Islands (BPI) and China Banking Corporation (China Bank) as initial noteholders, for the issuance of fixed rate corporate notes in the amount of Nineteen Billion Pesos (P19,000,000,000.00). SNAP Magat also appointed BPI, acting through its Asset Management and Trust Group, as facility agent and BPI Capital Corporation as mandated lead arranger and bookrunner. China Bank Capital Corporation acted as joint lead arranger for the said transaction. The proceeds of the notes will be used by SNAP Magat to, among others, repay its existing loans, finance its recapitalization and fund other general corporate purposes.

SN Aboitiz Power-Magat, Inc., a joint venture between AboitizPower and SN Power AS of Norway, is owner and operator of the 360-MW Magat Hydroelectric Power Plant located at the border between Ramon, Province of Isabela and Alfonso Lista, Province of Ifugao.
