

Item 9: Other Matters

Aboitiz Power Corporation (AboitizPower) was advised by its wholly owned subsidiary, Therma Power Visayas, Inc. (TPVI), that it received today the Notice of Judgement dated October 5, 2016 in the Supreme Court case number G.R. No. 212686 entitled "*Sergio R. Osmena III vs. Power Sector Assets and Liabilities Management Corporation, Emmanuel R. Ledesma, Jr., SPC Power Corporation and Therma Power Visayas, Inc.*"

In its Notice of Judgement, the Supreme Court upheld the validity of the public bidding held by the Power Sector Assets and Liabilities Management (PSALM) Corporation of the Naga Power Plant but invalidated the condition in the bidding granting SPC the right to top the bid. The Supreme Court ordered the reinstatement of the Notice of Award issued by PSALM dated April 30, 2014 awarding the 153.1-MW Naga Power Plant in Cebu to TPVI. The Supreme Court annulled and set aside the Asset Purchase Agreement (NPPC – APA) and the Land Lease Agreement executed (NPPC


– LLA) between SPC and PSALM and directed PSALM to execute the NPPC-APA and the NPPC-LLA in favor of TPVI.
