Item 9: Other Events

Aboitiz Power Corporation (AboitizPower) was advised by its affiliate, SN Aboitiz Power – Benguet, Inc. (SNAP-Benguet), that it received today, through a ceremonial awarding, a copy of the Certificate of Compliance (COC) from the Energy Regulatory Commission for all four (4) units of the Binga Hydroelectric Power Plant (HEPP) located at Brgy. Tinongdan, Itogon, Benguet, which has a capacity of 125.8 MW and economic life of 50 years. The COC is valid for five (5) years from the date of its issuance.

SNAP-Benguet is the owner and operator of the Ambuklao-Binga Hydroelectric Power Complex, consisting of the Ambuklao Plant located in Bokod, Benguet and the Binga Hydroelectric Power Plant located in Itogon, Benguet.
