Item 9: Other Events

Aboitiz Power Corporation (AboitizPower) was informed by its wholly-owned subsidiary, Therma Mobile, Inc. (Therma Mobile), that the Board of Directors of Manila Electric Company (Meralco) approved the signing of the Power Supply Agreement (PSA) between Therma Mobile and Meralco. The approval paves the way for the signing of the PSA between Therma Mobile and MERALCO for the supply of up to 234 MW of Therma Mobile's capacity. Once signed, the parties will file an application with the Energy Regulatory Commission (ERC) for the approval of the PSA. Power delivery will commence upon approval by the ERC and continue until June 2017.
