**Item 9: Other Events**

Aboitiz Power Corporation (AboitizPower) was informed that its wholly-owned subsidiary, Aboitiz Energy Solutions, Inc. (AESI), was one of the seven Highest Ranking bidders in the Selection and Appointment of the Independent Power Producer Administrator (IPPA) conducted by the Power Sector Assets & Liabilities Corporation (PSALM) for the 200 1-MW Strips of Energy of the Unified Leyte Geothermal Power Plant. AESI was awarded forty (40) 1-MW Strips of Energy, subject to a post-bid qualification process by PSALM on the accuracy, authenticity and completeness of all documents submitted with the bid.


Six other bidders also were also awarded Strips of Energy ranging from three to the maximum of 40 Strips. PSALM awarded all 200 Strips of Energy.
