Item 9: Other Events

Therma Mobile, Inc. (Therma Mobile) informed Aboitiz Power Corporation (AboitizPower) that the Energy Regulatory Commission (ERC), in its Order dated November 4, 2013, provisionally approved the Power Supply Agreement (PSA) between Manila Electric Company (MERALCO) and Therma Mobile. The approval paves the way for the delivery of up to 234 MW of Therma Mobile's capacity to MERALCO. The PSA is valid until June 25, 2017.


