**Item 9: Other Events**

Aboitiz Power Corporation (AboitizPower) was advised by its wholly-owned subsidiary, Aboitiz Energy Solutions, Inc. (AESI), that it received the formal Notice of Award for the Appointment of Independent Power Producer (IPP) Administrator for the Strips of Energy of the Unified Leyte Geothermal Power Plants (ULGPP). AESI have been awarded forty (40) strips of Energy (equivalent to 40MW) of the ULGPP at Php4.6629/kWh.


As previously disclosed, AESI was one of the seven Highest Ranking bidders in the Selection and Appointment of the IPP Administrator conducted by the Power Sector Assets & Liabilities Corporation (PSALM) for ULGPP's 200 1-MW Strips of Energy, subject to the post-bid qualification process conducted by PSALM.
