Item 9: Other Matters

Aboitiz Power Corporation (Aboitiz Power) received today the approval from The Philippine Dealing and Exchange Corporation (PDEx) to list the Php10 billion fixed-rate retail bonds, including oversubscription (the "Third Tranche Bonds"), out of its Php30-billion Debt Securities Program registered and approved by the Securities and Exchange Commission (SEC) on March 1, 2021.

The PDEx approval paves the way for the secondary market trading of the Series "D" Bonds, with a fixed interest rate of 5.3066% per annum maturing in 2027, and the Series "E" bonds with a fixed interest rate of 5.7388% per annum maturing in 2029.

The Company appointed the following for its Third Tranche Bonds: BDO Capital & Investment Corporation (BDO Capital), China Bank Capital Corporation (China Bank Capital), and First Metro Investment Corporation (FMIC) as Joint Issue Managers; and BDO Capital, China Bank Capital, FMIC, and Security Bank Corporation as Joint Lead Underwriters and Joint Bookrunners.
