Item 9: Other Matters

The Philippine Dealing and Exchange Corporation (PDEx) approved today the listing of Aboitiz Power Corporation's (AboitizPower) Series "A" Bonds equivalent to PhP8 billion, including oversubscription.

The PDEx approval paves the way for the secondary market trading of the Series "A" Bonds, with a fixed interest rate of 3.8224% per annum. The bonds will mature in 2026.

On March 1, 2021, the Securities and Exchange Commission (SEC) approved AboitizPower's public offer of its fixed rate retail bonds in the aggregate principal amount of up to PhP30 billion, to be issued in tranches. The remaining balance of the PhP30 billion bonds was lodged under the shelf registration program of SEC and may be raised in future tranches.
