During its special meeting held today, the Board of Directors of Aboitiz Power Corporation ("AboitizPower" or the "Company") approved the declaration of regular cash dividends in the amount of **PESOS: TWO PESOS AND 30/100 CENTAVOS (P2.30)** per share, to be paid from the Company's unrestricted retained earnings as of December 31, 2023.
