Item 9: Other Matters

Aboitiz Power Corporation ("Aboitiz Power") was informed by Aboitiz Power International Pte. Ltd. ("Aboitiz Power Intl.") that its planned acquisition of a 100% ownership interest in Mekong Wind Pte. Ltd. from Armstrong Southeast Asia Clean Energy Fund Pte. Ltd. ("AAM") was not completed due to a condition precedent being unmet by the agreed longstop date. As a result, Aboitiz Power Intl. decided to exercise its right to terminate the transaction.

AboitizPower Intl. is in discussions with AAM to revisit the acquisition at a future date.

The termination of the transaction has no impact to AboitizPower's existing operations and financial performance.
