Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its regular meeting held today, the Board of Directors of Aboitiz Power Corporation ("AboitizPower" or the "Company") approved the appointment of Mr. Manuel Alberto R. Colayco to replace Ms. Monalisa C. Dimalanta as Compliance Officer of AboitizPower, effective August 24, 2022.

Mr. Colayco, 52, Filipino, is currently the Corporate Secretary of the Company. He is Senior Vice President - Chief Legal and Compliance Officer/Corporate Secretary of Aboitiz Equity ventures Inc. ("AEV").

Mr. Colayco previously served as General Counsel of AGP International Holdings Ltd. and Atlantic, Gulf & Pacific Company of Manila, Inc. He was Executive Director and Assistant General Counsel of J.P. Morgan Chase Bank N.A. He was also Vice President and Legal Counsel of DKR Oasis (Hong

Kong) LLC and was Associate at Skadden, Arps, Slate, Meagher & Flom, LLP and Romulo Mabanta Buenventura Sayoc & de los Angeles law firms.

Mr. Colayco holds a Master of Laws degree from New York University School of Law, New York, U.S.A. and a Bachelor of Arts in Economics degree and a Juris Doctor from the Ateneo de Manila University, Manila. He is a member in good standing of the Integrated Bar of the Philippines and of the New York State Bar. He is not a director of any publicly-listed company, nor is he connected with any government agency or instrumentality.
