

#### Item 9: Other Events

Aboitiz Power Corporation (the "Company") was informed today by its wholly-owned subsidiary, Aboitiz Renewables, Inc. (ARI), that the Thunder Consortium, consisting of ARI, Electric Power Development Co., Ltd. (or J-Power), and Sumitomo Corporation, was declared as the highest-ranking bidder in the bidding process conducted by the Power Sector Assets and Liabilities Management Corporation (PSALM) Privatization Bids and Awards Committee for the privatization of the Caliraya-Botocan-Kalayaan Hydroelectric Power Plant Complex.

The Consortium will undergo the post-qualification process required by PSALM.
