Item 9: Other Events

Aboitiz Power Corporation (the "Company") was informed today by SN AboitizPower-Magat, Inc. (SNAP Magat) and SN AboitizPower-Benguet, Inc. (SNAP Benguet) that they have paid financial penalties to the Philippine Electricity Market Corporation (PEMC) for non-compliance with the Reserve Conformance Standards (the standards set in the Ancillary Services Monitoring Manual issued by PEMC and approved by the Department of Energy) for the billing period covering February 2025. The penalties for each entity are as follows:

The Company was informed that a majority of these non-compliances were technical in nature and were affected by factors beyond SNAP Magat and SNAP Benguet's control. On May 22, 2025, both SNAP Magat and SNAP Benguet made payments under protest to PEMC, reserving their right to contest the imposition. On July 9, 2025, the companies received PEMC's response to their letters, stating that the findings were final.

SNAP Magat and SNAP Benguet are joint venture companies of Aboitiz Renewables, Inc. (ARI) with SN Power Philippines Inc. (through Manila-Oslo Renewable Enterprise, Inc.). ARI represents the Company's investments and interests in various renewable energy projects.

While SNAP Magat and SNAP Benguet have paid the penalties, they continue to coordinate with the authorities to ensure compliance and to provide a reliable power supply to the grid.
