## Item 9: Other Events

Aboitiz Power Corporation (the "Company") was informed today by its wholly-owned subsidiary, Aboitiz Renewables, Inc. (ARI), that on July 18, 2025, the Power Sector Assets and Liabilities Management Corporation (PSALM) has issued a Notice of Award to the Thunder Consortium, composed of ARI, Sumitomo Corporation, and Electric Power Development Co., Ltd. (or J-Power), as the Winning Bidder for the sale and privatization of the Caliraya-Botocan-Kalayaan Hydroelectric Power Plant Complex. The Thunder Consortium will undergo the post-award processes required by PSALM.

ARI represents the Company's investments and interests in various renewable energy projects, including geothermal, large hydro, run-of-river hydro, wind, battery energy storage systems, and solar projects.
