Notice is hereby given that on 30 April 2025, a sworn Registration Statement was filed with the Securities and Exchange Commission for and on behalf of **ABOITIZ POWER CORPORATION** (the "Company") for the shelf registration of a Debt Securities Program in the aggregate principal amount of **up to One Hundred Billion Pesos** (\$\mathbf{P}100,000,000,000,000.00)\$ to be offered in one or more tranches (the "Debt Securities Program"), with the first tranche of the bonds to be offered in the aggregate principal amount of up to **Twenty Billion Pesos** (\$\mathbf{P}20,000,000,000.00)\$, with an oversubscription option of up to **Ten Billion Pesos** (\$\mathbf{P}10,000,000,000.00)\$.
