### Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its special meeting held today, the Board of Directors of Aboitiz Power Corporation (the "Company") approved the following changes in its officers.

- Resignation of Ms. Marnie F. Mañalac as Data Privacy Officer and Vice President for Risk and Organizational Performance Management of the Company, effective March 5, 2021; and
- 2. Appointment of Ms. Arazeli L. Malapad as the new Data Compliance Officer and Vice President for Risk and Organizational Performance Management of AboitizPower following the resignation of Ms. Mañalac, effective March 5, 2021.
  - Ms. Malapad, 53 years old, Filipino, has extensive experience in the fields of: audit, management reporting, financial planning and budgeting, treasury cash management,

general accounting, and tax compliance. She previously served as the Company's Assistant Vice President – Divisional Operating Profit from 2016 to 2018.

Ms. Malapad has held various positions in the Aboitiz Group, namely: Vice President – Controller of Pilmico Foods Corporation and its subsidiaries from 2018 to 2020, Assistant Vice President – Controller of Hedcor, Inc. from 2010 to 2016, Assistant Vice President – Controller of Luzon Hydro Corporation (LHC) from 2009 to 2010, and Finance and Accounting Manager of LHC from 2005 to 2009.

Ms. Malapad obtained her Bachelor of Science in Commerce, Major in Accounting Bachelor from the Immaculate Conception College. She completed the Leadership Management and Development Program in the Ateneo de Manila University Graduate School of Business where she was accorded the Director's Award for Academic Excellence. Ms. Malapad is a Certified Public Accountant, Certified Internal Auditor, Certified Management Accountant, and holds a Lean Six Sigma Green Belt certification. She is not connected with any government agency or instrumentality. She is not a director of any publicly-listed company.
