Item 9: Other Events

Aboitiz Power Corporation (AboitizPower) filed today with the Securities and Exchange Commission (SEC) a Registration Statement for the registration of its proposed fixed rate retail bonds in the aggregate principal amount of Php30 billion (the "Bonds"), to be registered under the shelf registration program of the SEC. The first tranche of the Bonds, equivalent to Php3 billion, will be offered to the general public in 2017. As the need arises, AboitizPower will issue subsequent tranches of the Bonds.

Proceeds from the first tranche of the Bonds will be used to finance an investment into a company partly owned by AboitizPower. For the first tranche, AboitizPower appointed BPI Capital Corporation as the Issue Manager and Underwriter, and BPI Asset Management and

Trust Corporation as the Trustee. AboitizPower intends to list the Bonds with the Philippine Dealing and Exchange Corp.
