Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its regular meeting held today, the Board of Directors of Aboitiz Power Corporation (the "Company") unanimously approved the appointment of Mr. Emmanuel V. Rubio as President and CEO of the Company effective January 1, 2020 and the retirement of Mr. Erramon I.Aboitiz from the Company, also effective January 1, 2020.

Mr. Rubio, 54 years old, Filipino, is currently the Chief Operating Officer of the Company, having been appointed to this role on June 1, 2018. He previously served as the Company's Executive Vice President and Chief Operating Officer - Power Generation Group from 2014 to June 2018.

Prior to joining the Company, Mr. Rubio was connected with Consolidated Industrial Gases, Inc.

(CIGI) Philippines, where he worked in various capacities, including Vice President for Sales and Marketing from 1996 to 2001, and eventually, President from 2003 to 2007.
