Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

In its regular Board Meeting today, the Board of Directors of Aboitiz Power Corporation (the "Company") approved the following matters:

1. Appointment of Mr. Chris B. Sangster as Executive Director – Power Generation Group effective May 15, 2017

Mr. Sangster first joined the Aboitiz Group in May 2008 as Vice President for Project Development of Hedcor, Inc., a wholly-owned subsidiary of AboitizPower. Prior to joining the Aboitiz Group, he also served as Executive Director for Operations of Luzon Hydro Corporation and Executive Manager for Asian Development and Operations of Pacific Hydro Pty Ltd from August 2005 to May 2008. He has over 20 years of experience in the power sector with

expertise on international development, construction, economic analysis, and technical and risk evaluations.

Mr. Sangster earned his Degree in Civil Engineering from the University of Adelaide and his Master's in Business Administration from Melbourne Business School.

2. Creation of the Position of Data Privacy Officer and Appointment of Mr. Ronaldo S. Ramos as Data Privacy Officer effective May 15, 2017

Mr. Ramos first joined the Aboitiz Group as Assistant Vice President for Business Risk Management of Aboitiz Equity Ventures, Inc. from 2009 to 2016. He has extensive experience in risk management, internal and IT audits and business process reviews. Prior to joining the Aboitiz Group, he was Senior Manager for Risk Advisory Services of KPMG Philippines; Operations Auditor of Petron Corporation; and Audit and Business Advisory Services associate of SGV & Co.

Mr. Ramos is a graduate of Bachelor of Science in Accountancy from De La Salle University and is a Certified Public Accountant, Certified Internal Auditor and Certified Information Systems Auditor. He has an International Certificate in Risk Management from the Institute of Risk Management.
