



### Item 9: Other Matters

Hedcor Inc. informed Aboitiz Power Corporation (AboitizPower) that a fine of Php200,000.00 was paid to the Pollution Adjudication Board (PAB), in connection with the DENR-PAB Case No. CAR-00874-16 entitled *In the Matter of the Water Pollution Control and Abatement Case versus Hedcor Inc., Hedcor Sabangan, Inc., and Sta. Clara International* (the "Case"), which involved the alleged illegal dumping of soil in the Chico River during the construction of the Hedcor Sabangan hydro-electric power plant, supposedly in violation of the Clean Water Act, Republic Act No. 9275.

The respondents in the Case were directed to pay the fine, and payment was made for and on behalf of all the respondents by Sta. Clara International, the contractor for the Hedcor Sabangan

hydro-electric power plant, in compliance with its contractual obligation and liability for the "care of water" during the construction of the plant.

Hedcor Inc. is the project company for AboitizPower's investments in mini-hydroelectric generation assets located in Northern Luzon and Davao City. Hedcor Sabangan, Inc. is the project company for the run-of-river hydro-electric power plant located in Sabangan, Mountain Province. Both Hedcor Inc. and Hedcor Sabangan, Inc. are wholly-owned subsidiaries Aboitiz Renewables Inc., AboitizPower's holding company for renewable energy projects.
