Item 9: Other Events

Aboitiz Power Corporation (Aboitiz Power) received today, June 16, 2017, a letter from the Markets and Securities Regulation Department of the Securities and Exchange Commission (SEC), informing the company that SEC, in its meeting yesterday, June 15, 2017, favorably considered the company's application for the issuance of up to Php30 billion fixed-rate corporate retail bonds. The bonds will be registered under the shelf registration program of the SEC and will be issued in tranches. The first tranche is equivalent to Php2 billion, with an oversubscription option of another Php1 billion. The final approval of the registration statement of the bonds will be issued upon Aboitiz Power's compliance of certain conditions, which include among others, the submission of certain documents to the SEC.
