### **Item 9: Other Matters**

Aboitiz Power Corporation ("AboitizPower") has received the Certificate of Permit to Offer Securities for Sale dated June 19, 2020 (the "Permit") from the Securities and Exchange Commission (the "SEC"). The Permit allows AboitizPower to issue the fourth tranche of its Php30 billion peso-denominated fixed-rate retail bonds registered under the shelf registration program of SEC on June 19, 2017.

The fourth tranche bonds, with the principal amount of PhP 6 billion and an oversubscription option of up to PhP 3.55 billion (the "Bonds"), will be issued on July 6, 2020. The offer period commenced on June 19, 2020 and will end on June 26, 2020.

The Company appointed BDO Capital & Investment Corporation, China Bank Capital Corporation and First Metro Investment Corporation as Joint Issue Managers and Joint Lead Underwriters; BDO Unibank, Inc. - Trust and Investments Group as the Trustee; and Philippine Depository & Trust Corp. as the Registrar and Paying Agent.
