Item 9: Other Matters

Today, July 17, 2020, Therma Mobile, Inc. (TMO) notified the Department of Energy (DOE) and the Energy Regulatory Commission (ERC) that it has withdrawn its request for de-registration from the Wholesale Electricity Spot Market (WESM) and disconnection from the Manila Electric Company (MERALCO) system, following the signing of an Ancillary Services Procurement Agreement (ASPA) between TMO and the National Grid Corporation of the Philippines (NGCP).

TMO and NGCP shall jointly file an application with ERC for the approval of the ASPA. In the meantime, TMO will not deregister from WESM and continue its commercial operations.

Previously, on June 3, 2020, TMO had notified MERALCO that it will physically disconnect from MERALCO's system and deregister as a Trading Participant in WESM effective July 15, 2020, in the absence of a Power Supply Agreement duly approved by the ERC.

TMO is a wholly-owned subsidiary of Aboitiz Power Corporation through Therma Power Inc., its holding company for its investments in thermal energy.
