#### Item 9: Other Events

During its regular board meeting held on July 25, 2019, the Board of Directors of Aboitiz Power Corporation (AboitizPower) appointed BDO Capital & Investment Corporation and First Metro Investment Corporation as Joint Issue Managers, Joint Bookrunners and Joint Lead Underwriters, and BDO Unibank - Trust and Investments Group as Trustee for the proposed issuance of the third tranche, with a base issue size of PhP 10 billion (and an oversubscription amount to be determined at a later date) (the "Third Tranche Bonds"), of the Company's Php30 billion fixed-rate retail bonds registered in 2017 under the shelf registration program of the Securities Exchange Commission (SEC).

The Company issued the first tranche on July 3, 2017 in the amount of Php3 billion, and the second tranche on October 25, 2018 in the amount of Php10.2 billion. Subject to market

conditions, the Third Tranche Bonds are expected to be offered to the general public in the second half 2019 and shall be listed with the Philippine Dealing and Exchange Corporation (PDEx) as and when issued.

The Board of Directors delegated to the Company's management the final determination of the issue amount, interest rate, offer price, tenors, and other terms and conditions of the Third Tranche Bonds as part of the book building process. As previously disclosed, proceeds of the Third Tranche Bonds will be used to finance planned acquisitions, future investments, and/or other corporate requirements.
