He was also the Regulatory Affairs Manager of AboitizPower from July 2013 to June 2014, and the Department Head for Billing and Collection of Visayan Electric Company, Inc. from March 2012 to June 2013. Prior to joining the Aboitiz Group, he served as Senior Associate for Transaction Advisory Services of SyCip Gorres Velayo and Co. from June 2010 to March 2011.

Mr. Aboitiz earned his Bachelor of Science Degree in Accounting from the Loyola Marymount University in Los Angeles, California, USA. He completed his Master of Business Administration from The Hong Kong University of Science and Technology, and completed the MBA International Exchange Program at the IESE Business School — University of Navarra in Barcelona, Spain.
