# Item 9: Other Events

Aboitiz Power Corporation (AboitizPower) filed an application today with the Securities and Exchange Commission (SEC) to issue the third tranche of its Php30 billion Debt Securities Program (the "Third Tranche Bonds"), registered with the SEC under its shelf registration program on 19 June 2017. The Third Tranche Bonds will consist of the primary offer of an aggregate principal amount of up to P10,000,000,000.00 with an oversubscription option of up to P2,000,000,000 and is expected to be offered to the general public during the fourth quarter of 2019.

AboitizPower will use the proceeds of the Third Tranche Bonds for (i) repayment of its short-term loan obligations and (ii) general corporate purposes.

For the proposed offering, AboitizPower has appointed: BDO Capital & Investment Corporation and First Metro Investment Corporation as Joint Issue Managers; BDO Capital & Investment

Corporation, First Metro Investment Corporation, China Bank Capital Corporation, SB Capital Investment Corporation, and PNB Capital & Investment Corporation as Joint Lead Underwriters; and BDO Unibank, Inc. - Trust and Investments Group as the Trustee. AboitizPower intends to list the Bonds with the Philippine Dealing and Exchange Corp.
