

**Item 9: Other Events**

Aboitiz Power Corporation (AboitizPower) was advised that GNPowder Mariveles Coal Plant Ltd. Co. (GMCP) signed today, August 29, 2017, a Notes Facility Agreement with a consortium of lenders, in the amount of up to US Dollars: Eight Hundred Million (US\$800,000,000.00). The noteholders are BDO Unibank, Inc., China Banking Corporation, Land Bank of the Philippines, Security Bank Corporation and Philippine Bank of Communications. BDO Capital & Investment Corporation is acting as sole mandated lead arranger. The proceeds of the notes will be used by GMCP to, among others, refinance its existing loans and for other general corporate purposes.

GMCP is a partnership among Therma Mariveles Holdings, Inc., and Therma Mariveles Camaya B.V., both AboitizPower subsidiaries, with Mariveles Coal Project GP Corp., Power Partners Ltd. Co., and AC Energy Holdings Inc.'s affiliates Arlington Mariveles Philippines GP Corporation, and Arlington Mariveles Netherlands Holdings B.V.


GMCP is a private limited partnership organized for the purposes of developing, financing, constructing, operating and owning an approximately 2x345 MW (gross) clean pulverized coal-fired power plant located at Mariveles, Bataan.
