#### Item 9: Other Events

Aboitiz Power Corporation (Aboitiz Power) received the approval of The Philippine Dealing and Exchange Corporation (PDEx) to list the third tranche of its Php30 billion debt securities program, equivalent to Php 7.25 billion (the "Series "D" Bonds").

The PDEx approval paves the way for the secondary market trading of the Series "D" Fixed Rate Bonds, with a fixed interest rate of 5.2757% per annum maturing in 2026.
