#### Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its regular meeting held on November 5, 2019, the Board of Directors of Aboitiz Power Corporation (the "Company") unanimously approved the following, with changes to take effect on January 1, 2020, except as otherwise indicated:

### 1. Appointment of Director

Mr. Emmanuel V. Rubio, the incoming President and Chief Executive Officer (CEO) of the Company effective January 1, 2020, will replace Mr. Luis Miguel O. Aboitiz as Director and as member of the Board Executive Committee. Mr. Rubio was also appointed as the Chairman of the Board Executive Committee effective January 1, 2020, pursuant to the committee's charter that the President and CEO of the Company will also be the

committee's Chairman. Mr. Erramon I. Aboitiz will become the Vice-Chairman of the committee.

Mr. Rubio was also appointed as a member of the Board Risk and Reputation Management Committee, replacing Mr. Mikel A. Aboitiz.

Mr. Luis Miguel Aboitiz will remain the Company's Chief Strategy Officer.

### 2. Appointment of Chairman and Vice - Chairman of the Board of Directors

Mr. Erramon I. Aboitiz was appointed as the Chairman of the Board of Directors, effective January 1, 2020, replacing Mr. Mikel A. Aboitiz. Mr. Erramon I. Aboitiz will also replace Mr. Enrique M. Aboitiz as a member of the Board Audit Committee.

Mr. Mikel A. Aboitiz will assume the role of Vice-Chairman of the Board of Directors. Mr. Enrique M. Aboitiz, the current Vice Chairman, will remain as a member of the Board of Directors.

### 3. Appointment of Officers/Expansion of Roles

(a) Mr. Jaime Jose Y. Aboitiz will take on an expanded role as Executive Vice President - Chief Operating Officer

Mr. Jaime Jose Y. Aboitiz, 57 years old, Filipino, is currently a Director of the Company, having held the role from 2004 to April 2007, and re-elected on May 18, 2009. Prior to assuming his new role, Mr. Aboitiz was the Company's Executive Vice President and Chief Operating Officer — Power Distribution Group. Mr. Aboitiz is also a member of the Board Executive Committee and of the Board Risk and Reputation Management Committee.

(b) Mr. Anton Mari G. Perdices was appointed as Senior Vice President and Chief Operating Officer – Power Distribution Group

Mr. Anton Mari G. Perdices, 47 years old, Filipino, replaced Mr. Jaime Jose Y. Aboitiz who was the Executive Vice President and Chief Operating Officer — Power Distribution Group. He is currently a Director and President and Chief Operating Officer of Visayan Electric Company Inc. (Visayan Electric), where he was instrumental in encouraging collaboration across the Power Distribution Group, decentralizing customer service centers, and improving overall customer satisfaction. Prior to joining Visayan Electric in 2014, Mr. Perdices was connected with the Aboitiz Group's construction business unit, where he was instrumental in building relationship with key stakeholders and in developing risk management and quality control, in keeping with the highest standard and requirements of the oil and gas industry.

Mr. Perdices holds a Bachelor of Business Administration degree in Management Information Systems from Loyola College in Maryland, U.S.A.

(c) Mr. Danel C. Aboitiz was appointed as Senior Vice President – Government Relations and Regulatory Affairs

Mr. Danel C. Aboitiz, 38 years old, Filipino, has served as Director of the Company since December 11, 2018. He is currently the President and Chief Operating Officer

of AboitizPower's Coal Business Unit, under which are AboitizPower subsidiaries and affiliates that own, manage, or operate coal-fueled power generation assets. These include Therma Luzon, Inc., Therma South, Inc., and Therma Visayas, Inc. He is also currently a Director of Pagbilao Energy Corporation and serves as a Member of the Board of Advisers of ACO.

(d) Mr. Alexander B. Coo was appointed as Chief Operating Officer of the Company's Renewable Power Generation Group

Mr. Coo, 48 years old, Filipino, shall head the Company's Renewable Power Generation Group, focusing on the various renewable business units which operate the Company's run-of-river hydros, large hydros, geothermal, and solar plants. He is currently President and Chief Operating Officer of the Company's subsidiary, AP Renewables Inc. Mr. Coo previously served as Vice President for Corporate Services of Therma Marine, Inc.

Prior to joining the Aboitiz Group, Mr. Coo held various positions in Linde Philippines, Inc. and Linde Phil (South), Inc., where he served as Managing Director from April 2015 to September 2016, National Sales and Marketing Director from 2013 to 2015, and General Manager from 2012 to 2013.

Mr. Coo graduated *cum laude* with a Bachelor of Science Degree in Chemical Engineering from the University of Santo Tomas. He has completed the Executive Education course from INSEAD Singapore and the Linde Executive Management Program from Linde University, Munich.

(e) Ms. Marnie F. Mañalac was appointed as Data Privacy Officer and Vice President for Risk and Organizational Performance Management. Ms. Mañalac replaced Ms. Noreen Marie N. Vicencio, who was transferred to the Company's wholly owned subsidiary, Hedcor, Inc. Ms. Manalac will also assume the position of Ex-officio member of the Company's Board Risk and Reputation Management Committee.

Ms. Mañalac, 53 years old, Filipino, will perform the functions of the Company's chief risk officer in her role as the Vice President for Risk and Organizational Performance Management of the Company, a position she has held since September 2019. She has made significant accomplishments in the Company, including the Company-wide implementation of the strategic management process using the Balanced Scorecard.

Prior to joining the Aboitiz Group, Ms. Mañalac served as an Independent Consultant and Trainer on Advanced Cost Management from 2008 to 2016, and Assistant to the Director of Student Life. She also held various positions in Manila Electric Company from 1990 to 2008.

Ms. Mañalac obtained her Bachelor of Science Degree in Industrial Engineering from the University of the Philippines. She is a Professional Industrial Engineer and a Certified Management Accountant.

(f) Mr. Sammy Dave A. Santos was appointed as Assistant Corporate Secretary effective November 5, 2019

Mr. Sammy Dave A. Santos, 35 years old, Filipino, is currently an Associate General Counsel for Governance and Compliance Team of AEV since July 2017. He also

currently serves as Corporate Secretary of various Subsidiaries of the Aboitiz Group, and Assistant Corporate Secretary of the Good Governance Advocates and Practitioners of the Philippines (GGAPP).

Mr. Santos has experience in practice areas of corporate law, corporate structuring, special projects, corporate housekeeping, corporate governance, and compliance for non-listed and publicly-listed companies. Prior to joining the Aboitiz Group, he was Legal Counsel for Alliance Select Foods International, Inc. from 2016 to 2017. He was also Counsel for the Privatization Group and Office of Special Concerns of the Department of Finance in 2016. He was a Junior Associate at the Law Firm of Quiason Makalinta Barot Torres Ibarra Sison & Damaso from 2014 to 2016.

Mr. Santos earned his Juris Doctor degree from the Ateneo Law School in 2013 and was admitted to the Philippine Roll of Attorneys in 2014. He also holds a degree of Master of Science in Industrial Economics from the University of Asia and the Pacific since 2006. He is a member of good standing with the Integrated Bar of the Philippines.

#### 4. Transfer of Officer

Mr. Felino Bernardo, currently the EVP and COO – Power Generation Group, will be transferred to head the Company's Coal Business Unit to replace Mr. Danel Aboitiz. He will focus on the day-to-day operations of the various thermal plants held by the Company's subsidiaries and affiliates, including Therma Luzon, Inc., Therma South, Inc., and Therma Visayas, Inc. Mr. Bernardo will also ensure that the Company's interests are properly represented in various joint ventures with partners.

# 5. Separation of Officer

Mr. Christopher B. Sangster will step down as an officer of AboitizPower effective today, following the end of his employment contract with the Group.
