Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its special Board Meeting held today, the Board of Directors of Aboitiz Power Corporation (AboitizPower) approved the following:

(a) Election of Mr. Danel C. Aboitiz as Director, to serve the unexpired term of Mr. Jon Ramon Aboitiz.

Mr. Aboitiz, Filipino, 37 years old, is currently the President and Chief Operating Officer (COO) of several power generation companies under AboitizPower's coal group - Therma Visayas Inc., Therma South Inc., and Therma Luzon Inc. He is also a director in Pagbilao Energy Corporation, STEAG State Power Inc. and Redondo Peninsula Energy, Inc. From 2016 to 2018, he also served as President and COO of AboitizPower's oil business units, East Asia Utilities Corporation, Therma Mobile, Inc. and Therma Marine, Inc., where he currently sits as Director.

Mr. Aboitiz also handled key positions in AboitizPower's renewable power generation companies from 2010 to 2016.

Mr. Aboitiz graduated with honors from the University of Edinburgh with an MA Degree in Philosophy and Politics. He also spent his gap year at the Beijing Language and Culture University, studying the Chinese language. Mr. Aboitiz speaks Filipino, English, Spanish, and Mandarin.
