1. PURPOSE

1.1. To define the organization's commitment in pursuing excellence in practices surrounding Safety, Health and Environment

2. SCOPE

- 2.1. This Policy applies to AboitizPower and subsidiaries under its operational control.
- 2.2. In consortiums or joint ventures in which AboitizPower does not hold control, AP's representatives shall observe this policy and shall promote the application thereof, to the extent possible

3. OWNERSHIP

- 3.1. AP President and CEO, Group COO, and BU COOs are accountable for ensuring compliance with this policy.
- 3.2. AP SHES Head is responsible for providing oversight and advisory functions on the effective implementation of SHE programs at business and functional levels to ensure alignment and consistency in management approach.
- 3.3. The responsible officers shall exert best efforts to extend the application of this Policy to subsidiaries that are not subject to the control of AboitizPower and to contractors, suppliers, and business partners.

4. POLICY

4.1. Policy Statements:

4.1.1. **Occupational Safety & Health**

AboitizPower strives to make health and safety visible, felt, and lived across the organization. This aims to help safeguard the safety and well-being of all employees, contractors, and stakeholders and ensure that everyone can fulfill their potential with dignity and equality in a safe and healthy environment. To do so, the company shall align with the following strategic commitments:

- Ensure that all relevant stakeholders are consulted and employees are represented in developing appropriate OSH programs and that collective agreements in OSH are considered to reduce business-specific OSH risks to as low as reasonably practicable;
- Assess and measure the effectiveness of processes and activities against set OSH objectives and OSH performance targets to continuously drive process improvement and;
- Continually improve OSH systems to deliver better results and drive innovation towards aligned business goals.
