During its regular meeting held today, and upon recommendation of the Board Environmental, Social, Corporate Governance Committee (ESCG) Committee, the Board of Directors of Aboitiz Power Corporation (the "Company") approved the following:

- a. Amendments to the Manual on Corporate Governance to reflect changes in: (i) the composition of the Board of Directors, Board ESCG Committee, Board Related Party Transactions Committee, and Board Cyber and Information Security Committee; and (ii) the inclusion of the duties and responsibilities of the Board Cyber and Information Security Committee;
- b. Amendments to the Board ESCG Committee, Board Audit Committee, and Board Risk and Reputation Management Committee Charters to align with the revisions to the Company's Manual on Corporate Governance; and

- c. Amendments to the General Trading Policy to shorten the mandatory trading blackout period in connection with the disclosure of quarterly and annual results of the Company.

Copies of the revised Manual on Corporate Governance and Board ESCG Committee, Board Audit Committee, and Board Risk and Reputation Management Committee Charters will be uploaded to the Company's website after editorial comments from the Directors have been addressed.
