Profile of Mr. Mark Angelou E. Dinglasan

Mr. Dinglasan, 34 years old, Filipino, has been AboitizPower's Audit Operations Head since October 2022. He was primarily responsible for ensuring that the Company's Internal Audit function provided independent, objective, and risk-based assurance, along with valuable insights and advice to enhance organizational operations, and led the end-to-end activities of the Internal Audit function, covering areas of core operations, support functions, information/operational technologies and cybersecurity, compliance, combined assurance, and data analytics.

He has been with the Company for over 10 years, holding various audit positions since 2014. He has over 13 years of experience in power generation, distribution, retail electricity, and banking industries.

He earned his Bachelor's degree in Accountancy with honors from the University of Batangas. He is a Certified Public Accountant, a Certified Internal Auditor, and a Lead Auditor for ISO/IEC 27001:2013 (Information Security Management Systems), ISO 22301:2012 (Business Continuity Management Systems), and ISO 9001:2008 (Quality Management Systems). Additionally, he is a Certified Asset Management Assessor by the Institute of Asset Management.

Mr. Dinglasan is not connected with any other publicly-listed company. He is not connected with any government agency or instrumentality.
