Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its special meeting held today, the Board of Directors of Aboitiz Power Corporation (AboitizPower or the "Company") unanimously approved the appointment of Mr. Danel C. Aboitiz as President and Chief Executive Officer of the Company effective on July 1, 2024 and the retirement of Mr. Emmanuel V. Rubio from the Company, effective at the end of June 30, 2024.

Mr. Aboitiz, Filipino, 42 years old, is the Company's Director and Chief Commercial & Stakeholder Engagement Officer. He concurrently holds various directorships within the Aboitiz Group. In October 2023, Mr. Aboitiz was appointed as Private Sector Representative for Mindanao for the Inter-Agency Investment Promotion Coordination Committee of the Department of Trade and Industry. He also serves as a Director of the Philippine Electricity Market Corporation, Vice Chairman of the Philippine Independent Power Producers Association, and Vice Chair of the Energy Committee of the Management Association of the Philippines.

Mr. Aboitiz has served in various capacities throughout the Aboitiz Group and has been extensively involved in the various Business Units of AboitizPower. From 2016 to 2018, Mr. Aboitiz served as President and Chief Operating Officer of AboitizPower's Coal and Oil Business Units. He also handled key positions in AboitizPower's renewable power generation companies from 2010 to 2016, including the SN AboitizPower Group and AP Renewables Inc.

Mr. Aboitiz graduated with honors from the University of Edinburgh with an MA Degree in Philosophy and Politics.
