Aboitiz Power Corporation (Aboitiz Power or the "Company") confirms full payment of its twelve-year 2014 Series 'B' Bonds maturing in 2026, amounting to Php3.4 billion (the "Bonds"). The payment was made through the Philippine Depository & Trust Corp. (the "Paying Agent") on September 10, 2021. The Bonds will cease to be listed with the Philippine Dealing and Exchange Corporation (PDEx) following the early redemption.

Attached is the letter submitted to PDEx containing the (i) Notice of Redemption to Bondholders, (ii) Certification from the Paying Agent, and (iii) the Certification from the Trustee for the Bonds.

Trust Agreement dated 27August 2014between Aboitiz Power

Corporation and BPI Asset Management and Trust Corporation

Gentlemen:

We refer to Section 6.04 on Optional Redemption of the Trust Agreement dated 27August 2014 (the "Agreement") between Aboitiz Power Corporation (the "Issuer") and BPI Asset Management and Trust Group (now, BPI Asset Management and Trust Corporation or "BPI AMTC").

In relation thereto, we hereby give notice of our intent to redeem the whole of the outstanding Series B Bonds issued 10September 2014 amounting to PESOS: THREE BILLION, FOUR HUNDRED MILLION ONLY (Php3,400,000,000.00).

Section 6.04 of the Agreement provides that "Prior to the Maturity Date, the Issuer shall have the option, but not the obligation, to redeem in whole (and not in part), any series of the outstanding Bonds on the following dates or immediately succeeding Banking Day if such date is not a Banking Day: (i) For the **Series B Bonds** – starting on the 7th year.

In view of the foregoing, and in your capacity as Trustee of the Bondholders, please inform all relevant Bond Holders of this notice and inform them of our intention to exercise our option to redeem in whole the Series B Bonds.

We will also be requesting the Philippine Depository and Trust Corp., as Registrar and Paying Agent of the Series B Bonds, to provide us with a statement of the Early Redemption Price, including accrued interest. A copy of this request letter is attached herewith, for your information and reference. Capitalized terms herein shall have the same meaning as that of the Agreement.
