Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

During its regular meeting held today, the Board of Directors of Aboitiz Power Corporation ("AboitizPower" or the "Company") approved the following changes in its officers.

- 1. Retirement of Mr. Saturnino Nicanor, Jr. as the Company's Internal Audit Head effective November 3, 2022; and
- 2. Appointment of Mr. Juan Pascual C. Cosare as the new Internal Audit Head of AboitizPower following the retirement of Mr. Nicanor, effective November 3, 2022.

Mr. Cosare, 37, Filipino, is currently Assistant Vice President – Audit of AboitizPower. He held various positions in the Company namely: Internal Audit Supervisor from 2012 to 2016, Internal Audit Manager from 2016 to 2018, and Audit Operations Head/Senior Manager from 2019 to 2021.

Mr. Cosare previously served as Senior Auditor of Hedcor, Inc. and Audit Supervisor of ANFLO Management and Investment Corp.

Mr. Cosare holds a Bachelor of Science in Accountancy (Cum Laude) from the University of the Immaculate Conception. He is a Certified Public Accountant, Certified Internal Auditor, Certified Asset Management Assessor taken in Singapore, Information Security Management Systems (ISMS) Lead Auditor Candidate taken in Malaysia as well as an ISO 45001:2018 OSH Management Systems Lead Auditor Candidate. Mr. Cosare is not connected in any other publicly-listed company. He is not connected with any government agency or instrumentality.
