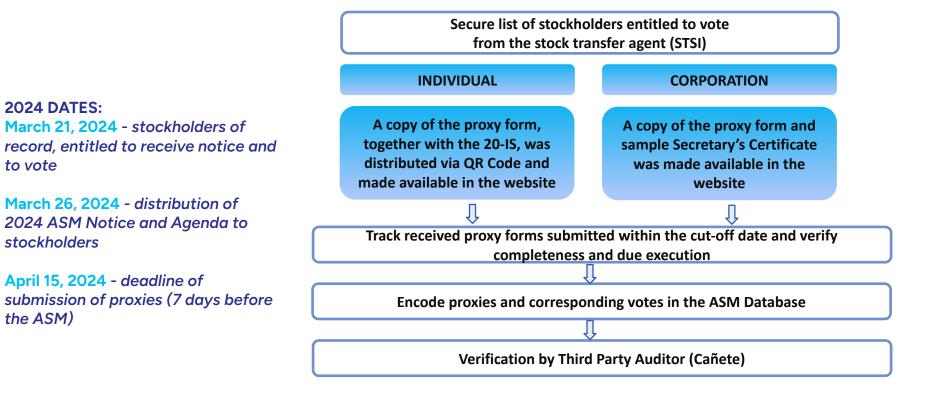

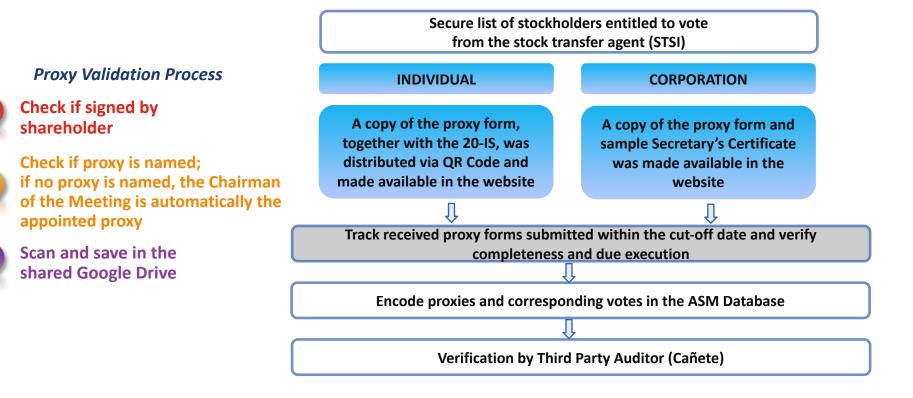

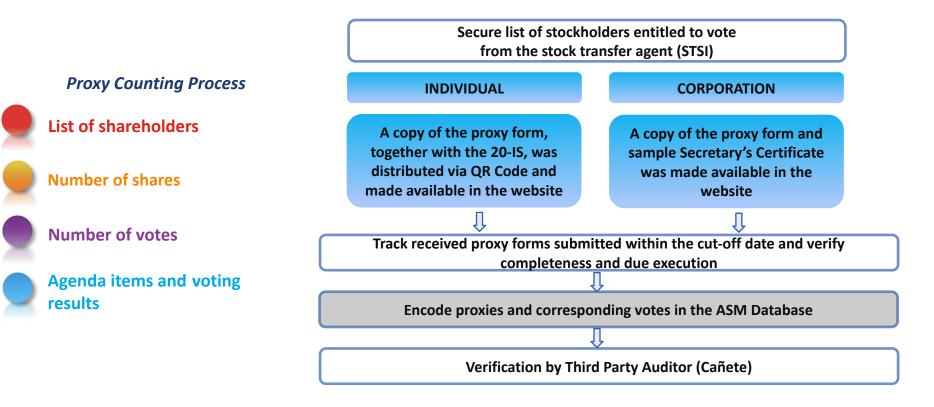

### Third Party Auditor Verification Process

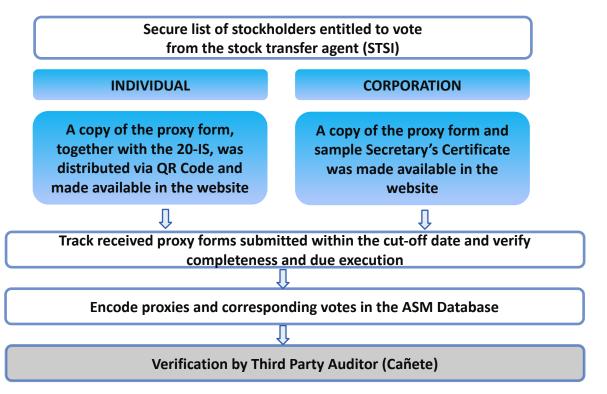
The Board of Election Inspectors (BEI) is given copies of all proxies received as of cut-off date for review
