Item 9: Other Matters

Therma Mobile, Inc. (TMO) notified Manila Electric Company (MERALCO) today, June 3, 2020, that it will physically disconnect from MERALCO's system and will deregister as a Trading Participant in the Wholesale Electricity Spot Market (WESM) effective July 15, 2020.

TMO's bunker-C fired diesel power plants located in Navotas, Metro Manila will be on reserve shutdown in the absence of a Power Supply Agreement duly approved by the Energy Regulatory Commission (ERC). Notices have also been sent to Philippine Electricity Market Corporation (PEMC), Independent Electricity Market Operator of the Philippines Inc. (IEMOP), Department of Energy (DOE), National Grid Corporation of the Philippines (NGCP), and ERC, pursuant to the notice

requirements under the Electric Power Industry Reform Act of 2001 (EPIRA), its implementing rules, and other relevant rules and regulations.

On February 5, 2019, TMO physically disconnected from MERALCO's system and deregistered as a Trading Participant in the WESM. Thereafter, TMO signed a PSA with MERALCO on April 26, 2019 for a term of one year. This contract has not been renewed and currently, TMO has no ERC-approved PSA.

TMO is a wholly-owned subsidiary of Aboitiz Power Corporation through Therma Power Inc., its holding company for its investments in thermal energy.
