Item 9: Other Events

SN Aboitiz Power-Benguet, Inc. (SNAP-Benguet), an affiliate of Aboitiz Power Corporation (AP), received the order from the Energy Regulatory Commission (ERC) provisionally approving the Ancillary Services Procurement Agreement (ASPA) between the company and National Grid Corporation of the Philippines (NGCP). Under the ASPA, SNAP-Benguet shall provide non-firm capacities for regulating reserve, contingency reserve, dispatchable reserve and blackstart capability from the Binga hydroelectric power plant. ERC's provisional approval will be effective for the next billing cycle subject to the following applicable maximum hourly rates:


Regulating Reserve PHP 3.00/kW/Hr
Contingency Reserve PHP 2.25/kW/Hr
Dispatchable Reserve PHP1.25/kW/Hr
Blackstart Capability PHP 2.14/kWh
